10 Year Limited Warranty

StyTek LLC expressly warrants the DripWave® Plus Insulation System for a period of ten (10) years from the date of purchase that it will perform to StyTek LLC's published product specifications found on its product literature and data sheets in effect at the time of installation, if installed in exact conformity with StyTek LLC's written installation guidelines or installation details approved in writing by StyTek LLC's corporate management, accepted industry standards (ASTM), and all applicable building codes in a properly designed, constructed, and structurally fit wall system. In the event of a warranty claim, StyTek LLC will replace defective DripWave® products and pay reasonable labor and material costs to correct leaks that result solely from the failure of the DripWave® products as expressly warranted above.

The installed system must include DripWave® EPS Panels or DripWave® Plus EPS Panels, DripWave® Mesh Tape or DripWave® Panel Tape, and DripWave® Weep/Vent Screed.

TO THE EXTENT PERMITTED BY APPLICABLE LAW, STYTEK LLC DISCLAIMS ALL OTHER WARRANTIES, GUARANTEES, CONDITIONS AND REPRESENTATIONS, EXPRESS OR IMPLIED, ORAL OR WRITTEN, STATUTORY OR OTHERWISE, INCLUDING BUT NOT LIMITED TO ANY IMPLIED CONDITIONS OR WARRANTIES AS TO THE MERCHANTABILITY OR FITNESS FOR A PARTICULAR PURPOSE.

Failure to give such notice within the time stated herein shall relieve StyTek LLC of all liability and any obligation to repair any leak otherwise covered by this warranty. Proof of purchase and date of installation must be included with all written claims. If StyTek LLC elects to investigate the claim, the claimant shall allow StyTek LLC's representatives reasonable access to the site and materials specified in the claim. This warranty is void if all parts of the total wall assembly in which the DripWave® Plus Insulation System is installed are not present and intact for inspection and/or testing by StyTek LLC.

If the installation or use of these products do not qualify for this ten (10) year warranty, StyTek LLC's DripWave® Limited Lifetime Product Warranty will apply.
